The Executive Director of the EDC is required to prepare an itemized budget to cover the proposed expenditures of the EDC for each upcoming fiscal year FY 2023-2024 Article V, Section 8 of the CCEDC's Bylaws state that the proposed budget is to be submitted to the Board 90 days prior to adoption.

The first draft of the budget was presented to the Board of Directors on May 24, 2023. No changes were requested at that time.
